Hi (b)(6)

Thank you for your email. The green turtle critical habitat designation is taking us much longer than first anticipated because of the number of DPSs (6) and vast areas of their ranges. We do not have an expected completion date at this time. Because we are required by the ESA to designate critical habitat, I'd like to continue to work with our DoD partners, as INRMPs are revised.

While reviewing the INRMPs, we've noticed that some address green turtle terrestrial nesting habitat, which falls under FWS jurisdiction, but most do not address marine habitat, which falls under NMFS jurisdiction. The types of issues NMFS would be concerned with would be: nearshore obstructions off nesting beaches (i.e., structures or activities that prevent or delay females from moving on and off nesting beaches and hatchlings from moving off nesting beaches), loss of seagrass or other foraging habitat, and offshore obstructions or activities that might block migratory routes between adult foraging and nesting areas. Please let me know if you have any ideas about sharing this information with all installations that include marine habitat of green turtles and that may be interested in an exemption. We do not have a biological report to share at this time, but we could give them some ideas of what we are looking for because I know that revising INRMPs takes a great deal of time and planning.
